

HON. ROGER N. ROSENGARTEN (Ret.)

Justice of the Supreme Court, Queens

Justice Roger N. Rosengarten brings a wealth of judicial experience and legal expertise to NAM's Metro Panel.

As a Justice of the Supreme Court for 15 years and a Judge of the Civil Court, Queens County for 7 years, Justice Rosengarten presided over a wide variety of complex civil cases. He has particular expertise in medical malpractice cases, having served as law secretary to Judge Fred T. Santucci, who handled the medical malpractice part in Supreme Court, Queens County. Subsequently, as a Judge in his own right, Hon. Rosengarten received countless trial assignments based on his proficiency in this area of law.

During his tenure on the bench, Justice Rosengarten presided over significant cases, with issues grounded in Labor Law, Products Liability, Construction and Premises Liability.

According to the 2013/2014 New York Judge Reviews, Hon. Rosengarten received high praise for judicial temperament, fairness and legal acumen. Quoting from the Judge Reviews: "There are only a couple of judges in Queens County that people in the building think can handle complicated cases like medical malpractice and he is one of them." Lawyers interviewed described him as "very professional....excellent trial judge....straight shooter....very fair". Across the board, he is regarded as "a very competent trial judge, capable of effectively handling the most complex cases."
